

## ENERGY-EFFICIENT HOUSING PROGRAM REFUND APPLICATION

As a Genworth-insured mortgage holder purchasing an energy-efficient home or refinancing for renovations to improve energy efficiency, you are eligible to receive a 10 per cent premium refund. You will also get access to Genworth Financial's Homebuyer Privileges™\* – an exclusive on-line discount program for commonly purchased household items. To make the program even more attractive, Genworth is making it available on loans with up to 40-year amortization periods at standard mortgage insurance premium rates.

### HOW TO GET YOUR REFUND

To qualify for a premium refund, you must meet the eligibility requirements below:

- Purchasing a home:**
  - Supply documentation certifying your home is EnerGuide Rated 77+ or R2000\*\*.
  - Your home must have been purchased on or after January 1, 2005
  - For condominium units, the entire building in which the unit you have purchased must be rated Energy Efficient (refer to your builder).
- Renovated existing homes:**
  - Supply documentation to certify that energy-efficient improvements have been made to increase its EnerGuide rating by at least five points to a minimum EnerGuide rating of 40.
  - Your renovated home improvements must have been funded on or after January 1, 2005
